**DECLARATION OF JAN VAN VOORN** IN SUPPORT OF ISSUANCE OF SUBPOENA PURSUANT TO 17 U.S.C. § 512(h)

I, Jan van Voorn, the undersigned, declare that:

- 1. I am Executive Vice President and Chief of Global Content Protection for the Motion Picture Association, Inc., on behalf of Columbia Pictures Industries, Inc., Disney Enterprises, Inc., Universal City Studios Productions LLLP, and Warner Bros. Entertainment, Inc. ("ACE Members") who are members of the Alliance for Creativity and Entertainment ("ACE"), a global coalition of leading content creators and on-demand entertainment services committed to supporting the legal marketplace for video content and addressing the challenge of online piracy. The ACE Members, whether themselves or through subsidiaries and affiliates, own the copyrights in the below referenced copyrighted works.
- 2. The ACE Members (via the Motion Picture Association, Inc.) are requesting issuance of the attached proposed subpoena that would order Cloudflare, Inc. to disclose the identities, including names, physical addresses, IP addresses, telephone numbers, e-mail addresses, payment information, account updates and account histories of the users operating the huhu.to website and service. Huhu.to utilizes Cloudflare servers to facilitate access to infringing

content by connecting users of the "Watched" mobile application to cyberlockers containing infringing content. For example, huhu.to has facilitated access to infringing content located on the following websites:
